As used in this resolution, the term "Manager" means the person or persons designated by the members of the LLC in a manager-managed LLC to manage the LLC as provided in the Certificate of Organization or an operating agreement. The term "Designated Member" means the member or members of the LLC authorized to act on behalf of the LLC in a member-managed LLC. By signing this resolution, Manager or Designated Member represent that they have provided PSECU with true and complete copies of the Certificate of Organization and operating agreements of the LLC as amended to the date of this resolution.

## The LLC named on this resolution resolves that:

- (1) PSECU is designated as the depository for the funds of the LLC and to provide other financial accommodations indicated in this resolution.
- (2) This resolution shall continue to be in effect until express written notice of its rescission or modification has been received and recorded by PSECU. Any and all prior resolutions adopted by the Managers or Designated Members of the LLC and certified to PSECU as governing the operation of this LLC's account(s) are in full force and effect until PSECU receives and acknowledges an express written notice of its revocation, modification, or replacement. Any revocation, modification, or replacement of a resolution must be accompanied by documentation, satisfactory to PSECU, establishing the authority for the changes.
- (3) The signature of an agent on this resolution is conclusive evidence of their authority to act on behalf of the LLC. Any agent, so long as they act in a representative capacity as an Agent of the LLC, is authorized to make any and all other contracts, agreements, stipulations, and orders which they may deem advisable for the effective exercise of the powers indicated on page one, from time to time with PSECU, subject to any restrictions on this resolution or otherwise agreed to in writing.
- (4) All transactions, if any, with respect to any deposits, withdrawals, and borrowing by or on behalf of the LLC with PSECU prior to the adoption of this resolution are hereby ratified, approved, and confirmed.
- (5) The LLC agrees to the terms and conditions of any account agreement properly opened by any agent of the LLC. The LLC authorizes PSECU, at any time, to charge the LLC for all checks, drafts, or other orders for the payment of money that are drawn on PSECU, so long as they contain the required number of signatures for this purpose.
